3. Upon acceptance of this application by the Cooperative the membership shall be deemed a Shared Membership where application has been made by two or more parties jointly, and any subsequent "Application for Electric Service" shall be deemed joint.
4. Applicant shall not resell any electric energy purchased from the Cooperative.
5. The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative including the terms set forth above. Thereafter applicant, upon receipt of service from the Cooperative, shall be issued membership in the Cooperative and shall thereafter be a member of the Cooperative.

The undersigned (hereinafter called "Applicant"), hereby applies for electric service at the premises identified by the location number at upper right and agrees to purchase electric service from Coles-Moultrie Electric Cooperative, (hereinafter called "Cooperative"), upon the following terms and conditions.

1. Applicant will, when electric service becomes available, purchase from the Cooperative all electric service used on the premises and will pay therefore at rates which will be fixed by the Board of Directors of the Cooperative.
2. Applicant agrees to pay for the electric service provided or available according to the rate schedules of the Cooperative.
3. Applicant will comply with and be bound by the provisions of the By-laws of the Cooperative, and such rules and regulations as may, from time-to-time, be adopted by the Cooperative.
4. Applicant shall not resell any electric energy purchased from the Cooperative.
5. Applicant will cause the premises of the applicant where the electric service is to be provided to be wired in accordance with wiring specifications approved by the Cooperative.
6. Applicant agrees that assessments for electric service shall include payment for a subscription to "Coles-Moultrie Hi-Lites," or its successor publication, published by the Cooperative.
7. In the event applicant requests installation of any underground service, applicant agrees to furnish the Cooperative with a detailed drawing to scale showing the location of all underground wires, conduits, pipes, tiles, drains, sewers, drainage structures and any other underground installations located along the course of the proposed underground service installation.
8. The acceptance of this application by the Cooperative shall constitute an agreement including the terms stated above. If no other acceptance is made by the Cooperative, the furnishing to the applicant of the service requested in this application shall be deemed acceptance of the application.
