

APPLICATION FOR CLASS B MEMBERSHIP

The undersigned (hereinafter called the "Applicant"), pursuant to the following terms and conditions, hereby applies for Class B membership of Coles-Moultrie Electric Cooperative (hereinafter called the "Cooperative") and agrees to purchase services other than electric energy service from the Cooperative,

The Premises for the membership are:

1. The Applicant, if requested by the Cooperative, may be required to provide a security deposit as determined by the Cooperative.
2. The Applicant agrees that the services other than electric energy service to be obtained from the Cooperative will be in accordance with a contract or agreement entered into between the Cooperative and the Applicant.
3. The Applicant agrees that, if the Applicant hereafter becomes a Class A member of the Cooperative, the Applicant's Class B membership will cease.
4. The Applicant agrees, pursuant to this Agreement, to comply with and be bound by the provisions of the articles of incorporation, bylaws, policies, rules, and regulations of the Cooperative as they now exist or as they may, from time to time, be adopted or amended by the Cooperative and further agrees to retroactive application of any amendments.
5. The Applicant agrees to allow such access to the Applicant's premises as is necessary to provide the services other than electric energy service requested by the Applicant.
6. The Applicant, by becoming a member, assumes no personal liability or responsibility for any debts or liabilities of the Cooperative, and it is expressly understood that, under the law, Applicant's private property is exempt from execution for any such debts or liabilities.
7. Acceptance of this application by the Cooperative shall establish a membership. The membership shall continue in force until either party terminates the membership of Applicant in accordance with the bylaws, policies, rules and regulations of the Cooperative. Removal or disconnection of the service at any time by the Cooperative, whether to discontinue service for an unpaid account or for any other reason, shall not constitute a breach of either the membership or the agreement for services other than electric energy service.
8. Falsification of any information in this Application may result in disconnection of service without notification.
