The undersigned (hereinafter called "Applicant") hereby applies for membership with Coles-Moultrie Electric Cooperative (hereinafter called "Cooperative") upon the following terms and conditions:

1. Applicant desires electric service and will execute an "Application for Electric Service."
2. Applicant will comply with and be bound by the provisions of the By-laws of the Cooperative, and such rules and regulations as may, from time to time, be adopted by the Cooperative.
3. Upon acceptance of this application by the Cooperative the membership shall be deemed a Shared Membership where application has been made by two parties jointly, and any subsequent "Application for Electric Service" shall be deemed joint.
4. Applicant shall not resell any electric energy purchased from the Cooperative.
5. The acceptance of this application by the Cooperative shall constitute an agreement between the Applicant and the Cooperative including the terms set forth above. Thereafter applicant, upon receipt of service from the Cooperative, shall be issued membership in the Cooperative and shall thereafter be a member of the Cooperative.

The undersigned (hereinafter called "Applicant"), hereby applies for electric service at the premises identified by the location number at upper right and agrees to purchase electric service from Coles-Moultrie Electric Cooperative, (hereinafter called "Cooperative"), upon the following terms and conditions:

1. Applicant will, when electric service becomes available, purchase from the Cooperative all electric service used on the premises and will pay therefore at rates which will be fixed by the Board of Directors of the Cooperative. **Applicant will pay a service and connection fee of \$40.00. A security deposit may also be required.**
2. Applicant agrees to pay for the electric service provided or available according to the rate schedules of the Cooperative.
3. Applicant will comply with and be bound by the provisions of the By-laws of the Cooperative, and such rules and regulations as may, from time-to-time, be adopted by the Cooperative.
4. Applicant shall not resell any electric energy purchased from the Cooperative.
5. Applicant will cause the premises of the applicant where the electric service is to be provided to be wired in accordance with wiring specifications approved by the Cooperative.
6. I request and authorize the cooperative's board of directors to subscribe to "Coles Moultrie Highlights" on my behalf and authorize the subscription price thereof to be deducted from any funds accruing in my favor, so as to reduce such funds in the same manner as would any other expense of the Cooperative.
7. In the event applicant requests installation of any underground service, applicant agrees to furnish the Cooperative with a detailed drawing to scale showing the location of all underground wires, conduits, pipes, tiles, drains, sewers, drainage structures and any other underground installations located along the course of the proposed underground service installation.
8. Applicant shall not construct, install, build, improve, repair or otherwise engage in construction activities that would cause an existing or planned building or structure of any kind to violate the National Electric Code, the National Electric Safety Code or any other applicable statute, regulation, or rule of local, state, or federal government that is now or may in the future limit the construction, repair, or maintenance of buildings or structures located in proximity to electrical lines.
9. The acceptance of this application by the Cooperative, by execution of this document or by providing electric service to the premises of the Applicant, shall constitute and agreement between the Applicant and the Cooperative the terms of which are set forth in this Application and Agreement for Electric Service, the By-laws of the Cooperative, the policies of the Cooperative, and such rules and regulations as may be adopted by the Cooperative, all as amended from time to time, in the sole discretion of the Cooperative.
