

COLES-MOULTRIE ELECTRIC COOPERATIVE

APPLICATION FOR INSTALLATION AND USE OF AREA LIGHT

The undersigned (hereinafter called the "Member") hereby applies for Area Lighting Service from Coles-Moultrie Electric Cooperative (hereinafter called the "Cooperative") upon the following terms and conditions:

1. The member requests that an Area Light be installed at his premises:

- _____ a. on Cooperative's existing transformer or service pole
- _____ b. on Member's pole or structure

2. Cooperative shall furnish, install and maintain a _____ watt Area Light.

3. Cooperative shall furnish the electric energy for operation of Area Light from dusk to dawn, controlled automatically by a photoelectric cell. Cost of the electric energy will be included in:

(Check one)

- _____ a. a flat rate of _____ plus Wholesale Power Adjustment plus 5% Illinois Utility Tax.
- _____ b. the Member's regular electric bill, as provided for in Area Lighting Schedule SLS, paragraph III.

4. Payment for Area Lighting Service hereunder shall be made each month together with and at the same time as the regular bill and shall be subject to the same terms for payment as for metered electric service.

5. The acceptance of this application by the Cooperative shall constitute an agreement between the Cooperative and the Member and shall continue in force for a minimum initial period of one year from the installation date of the Area Light and thereafter on a month to month basis until terminated by either party giving not less than 30 days written notice to the other. A member may discontinue Area Lighting Service during the initial period by paying immediately for the balance of the initial period at the monthly rate provided for in Schedule SLS, paragraph III.

6. Member agrees to report promptly to the Cooperative if the Area Light should fail to operate properly and agrees maintenance shall be rendered only during regular office hours within a reasonable time after notification.

7. Member agrees to exercise reasonable diligence in protecting the Area Lighting equipment from willful or deliberate damage.

8. Ownership of the Area Light and all necessary appurtenances shall be vested in the Cooperative and shall not be removed from premises where installed except by the Cooperative.

9. Upon discontinuance of the Area Lighting Service for any reason, the Cooperative shall have the right to remove all or any part of its facilities.

10. The Member hereby releases the Cooperative from all liability for any and all claims resulting from failure of the Area Light and agrees to make no attachments of any kind to the Area Lighting Facilities.

11. The Member agrees to pay \$ _____ to the Cooperative as the cost of making electric service available to the location desired, which is approximately described as follows:
